Health and Safety Executive (HSE) regulations place a legal duty on all employers and companies to provide full information, instruction and training to all their employees who may be exposed to asbestos containing materials. (Regulation 4, Control of Asbestos Regulations 2012)

Training falls into 3 categories:

- Asbestos awareness training
- Training for non-licensable asbestos work
- Training for licensable asbestos work

To ensure HSE compliance all employees working with or have the potential for asbestos exposure, require asbestos awareness training with a refresher course every 12 months.

GROSVENOR POWER SERVICES

Connah's Quay is a new 24 bay 400kV Gas Insulated Switchgear building which is replacing the existing Deeside Air Insulated Switchgear compound, the site is located in north wales on the Dee estuary, we are carrying out the M & E installation on behalf of EAC (Electricity Alliance Central) for National Grid.

The Gas used is SF6 – Sulphur hexafluoride, which has excellent insulating properties, but can be extremely harmful to the environment if inadvertently released, there are stringent measures that are put in place on all sites using SF6 by ourselves and our clients.

All works during the installation prior to energisation were controlled by a Client permit system and working to RAMS (Risk Assessment & Method Statement)

Once the site became live (under rules) all tasks had to be carried out under a National Grid Permit.

Some of the tasks carried out during the installation were:

- Above ground earthing
- Installation of GIS / GIB
- Installation of AIS equipment
- Installation of relay panels
- Installation of multi core cables
- Glanding & Terminating of multi core cables
- Installation of gantries

COMPLIANCE vs COMPETENCE

A common debate I have, Compliance vs Competence, what is the difference? Is simply being compliant enough? Does a ticket equal competence? And how is competence measured?

Compliance is 'acting in accordance with health & safety rules & legislation'. Compliance is a minimum requirement, while competence goes above and beyond that. The definition of competence from the HSE website: "To be competent an organisation or individual must have sufficient knowledge of the tasks to be undertaken and the risks involved. They must have the experience and ability to carry out their duties in relation to the project, to recognise their limitations and take appropriate action to prevent harm to those carrying out construction work, or those affected by the work."

Competence develops over time. Is a mix of initial & onjob training, instruction, assessment & formal quals.

The difference between compliance and competence can be thought of as: Passing and getting your driving license

you are compliant; you know how to drive and all the rules & theories of the road. But are you a competent driver? You are now on your own and putting the knowledge you have learned into practice. But without experience you are only compliant.
